You are entitled, if you prefer, within the same period of 15 days:

1. To apply forto be given a place at another school maintained by this council **or**
2. To apply for to be given a place at a school maintained by another local education authority, in which case you must also inform this council of your application within those 15 days **or**
3. To apply forto be given a place at a non-maintained (independent) school without asking this council to pay for such place, in which case you must also inform this council of your application within those 15 days.
