MEMBERS' ALLOWANCES – PUBLICATION OF ALLOWANCES PAID TO MEMBERS IN THE  
2002/2003 FINANCIAL YEAR

As part of the legislation that sets out the arrangements for the payment of allowances, details of amounts paid to each Member of the Council must be published in a local newspaper. This notice sets out the relevant information for the 2002/2003 financial year.

During the 2002/2003 financial year, the Council operated two different Allowance Schemes. From the 1st April to the 5th May 2002, the scheme in operation provided for the payment of the following allowances:

Basic Allowance – Each Member of the Council received £533

Special Responsibility Allowance – This allowance was paid for the following additional responsibilities:

The Council made a new scheme for Members Allowances at a meeting of the Council on the 15 April 2002. The scheme now operating, which took effect from the 6 May 2002, provides for Member Allowances appropriate for a Council operating a Mayor and Cabinet form of political structure. Public Notice was given to the new scheme on the 29 May 2002. The new scheme provides for:

- A basic allowance for each Member
- The positions attracting special responsibility allowances to not exceed 40 with 10 of these positions being reserved for the Lead Members on Community Forums
- Job profiles for Councillors and for the positions attracting special responsibility allowances
- No payments to be made for representing the Council on an outside body other than the Lead Members on Community Forums
- The payment of childcare and dependants' allowance.
- Payments to automatically rise annually in line with staff pay awards effective from the 1 April each year

From the 6 May 2002 the following allowances applied:

Basic Allowance per Councillor (excluding the Mayor) £9,200

Special Responsibility Allowance – This allowance was paid for the following additional responsibilities:

Schedule 1 details those Members who served for the whole of the year and the amounts they received under the two schemes. Schedule 2 details those Members who served from the 1 April to 5 May 2002 and the amounts they received under the first scheme. Schedule 3 details those Members who served from the 6 May 2002 to the 31 March 2003 and the amounts they received under the second scheme.
