

## **Newham Under the Stars Giveaway: Soul II Soul T-Shirt Competition for Newham Mag Issue 396**

### **Terms and Conditions**

#### **1. Who is running the T-Shirt Competition?**

This T-Shirt Competition is run by the Newham Mag, London Borough of Newham of Town Hall, Barking Road, East Ham, London, E6 2RP (**LBN**).

#### **2. How the T-Shirt Competition Works**

- 2.1 Newham residents who will successfully answer the question “*How many years in the music business as a collective are Soul II Soul celebrating this year?*” which will appear in issue 396 of the Newham Mag, will be in with a chance of winning an official Soul II Soul T-Shirt.
- 2.2 Newham residents will be able to enter the competition by emailing their answer to [events@newham.gov.uk](mailto:events@newham.gov.uk), by a given deadline. The final winners will be chosen via a random ballot.
- 2.3 The winners will be notified by email (using the detail provided upon registration) within 48 hours of the closing date and time of the competition. Winners will then need to confirm which size t-shirt they require.
- 2.4 The winners' notification will include details of when the T-Shirts will be ready for collection from Newham Dockside, 1000 Dockside Road, London, E16 2QU.
- 2.5 By taking part in the competition, participants are deemed to have accepted and agreed to be bound by these terms and conditions.
- 2.6 T-Shirts will only be distributed upon successful review of the proof of address and photographic identification.
- 2.7 If the winner does not claim the T-Shirts by attending the specified collection location or does not respond within 48 hours of being notified of winning, LBN will withdraw the offer of T-Shirts and re-allocate the T-Shirts without further notice.
- 2.8 LBN accepts no responsibility for entries which are not accepted (whether at all or before the closing date and time) due a technical failure, fault or interruption, loss of connectivity or server failure.
- 2.9 Results of the Soul II Soul T-Shirt competition are final and not open to dispute. No correspondence will be entered into in this regard.
- 2.10 LBN accepts no responsibility for applicants not receiving their notification of winning email due a technical failure, fault or interruption, loss of connectivity or server failure.

### 3. **Eligibility Criteria**

3.1 In order to be eligible to win a T-Shirt, competition participants must comply with the following eligibility criteria;

3.1.1 must be a current resident of the London Borough of Newham

3.2 Proof of home address **and** photographic ID must be shown on collection of the T-Shirts.

3.3 One of the following is accepted as proof of address; a council tax bill, household bill or bank statement each of which must be dated within the last 3 months.

3.4 One of the following is accepted as photographic ID; photo driver's licence or passport.

### 4. **T-shirt conditions**

4.1 The T-Shirts are not for re-sale and no cash alternative will be offered.

4.2 The T-Shirts are supplied to LBN by third parties. LBN have no liability if LBN can no longer supply the advertised T-Shirts due to circumstances beyond its reasonable control.

4.3 The winners of the T-Shirts are responsible for covering the cost of their own subsistence including travel costs for collecting the T-Shirts.

5.1 All data captured will be used in accordance with [Newham Council Data Protection Statement](#).

5.2 As referred to above, the data you provide to LBN upon registration may be used to confirm you meet the Eligibility Criteria by checking such data against that which is already held by LBN and data about you which is held by third parties.

5.3 By entering the T-Shirt competition, you consent to your name being provided to third parties for auditing purposes.

6.1 LBN reserves the right to amend or withdraw this offer at any time, including where it suspects fraudulent behaviour.

6.2 These terms and conditions will be governed by English law and applicants submit to the exclusive jurisdiction of the English courts.
