2. Commonwealth Games 2022 –(29 July to 1 August 2022)		
An overview and venue timetable of the Commonwealth Games 2022 to be held in July 2022 (CWG22) was shared with members. Games will consist of 20 medal events, sports track and Para track cycling over 4 days of competition. Tenancy from 9 July through to the 9 August 2002 with Athlete training dates from 22 July to 28 July.		
Organisers are working closely with venue operators on logistics planning and are also aware of the security and stewarding shortage challenges. There is ongoing dialogue with the MPS, LAS and LFB and upcoming focus on C3. Further details on HVM still to be finalised.	CWG22
