

Core Conversations training

Friday 15 July, 12:00-14:00

This service provision training module is about the practice of having a good initial conversation with residents who present with a range of welfare issues. The focus is on relationship building and non-judgemental understanding; not a time bound service with standard output, but support that could be varied depending on the person and situation.

This is a practice oriented session based on real scenarios, and we will be simulating conversations and practicing and learning from each other.

It's a two-hour training, and we ask if possible for attendees to complete a 25 minute preparation task before attending the session.
