 4.1 CT presented the purpose for the planned co-production workshop 4.2 The workshop is an opportunity to co-produce the definition of co- production and what it means. 4.3 The agenda will cover What works well? What are the opportunities? What could we improve or develop? What is important to you when coproducing? How can we ensure that our work is representative of the diversity of the borough? How can we encourage more residents to get involved? What is the role of the coproduction forum? 	
 4.4 RS asked if there has been thought given inviting partners who do co-production or would like to do it better to maximise the learning and maximise the reach 4.5 CT welcomed the suggestion to extend the invite to partners. Action: AK to send a calendar invite and include partners to the co-production workshop 4.6 CT noted that following the workshop, we will co-produce a report for reflection. Accessible Events Checklist with Angus McKenzie Davie, Greenhill Cumberland and Sophie Ibotson, Co-Production Services Officer	
 5.1 SI introduced the Accessible Event Checklist. 5.2 Following several concerns raised by forum members and residents about accessibility at Newham led events. Lack of accessibility such inadequate signposting cause confusion and anxiety. 5.3 SI formed a Task Group with residents to discuss how events can be more accessible. The group co-produce the checklist. 5.5 AMD noted accessibility is about the Social Model of Disability and removing barriers. 5.6 AMD went through parts of the checklist and pointed out such things as the importance of considering travel and arrival at a venue being just as important as the accessibility of the venue itself. 5.7 AMD gave an example that the forum forget to cover Housekeeping. 	
5.7 AMD gave an example that the forum forgot to cover Housekeeping at the start of the meeting. Housekeeping is vital in delivering accessible events.5.8 The checklist is a live document that can be amended as and when	
 issues come up. 5.9 The checklist covers, physical spaces, other needs, digital events, communication needs, information accessibility, and useful resources with links to further information. 5.10 Next Steps: Natalie Orringe, Assistant Chief Executive Marketing Officer for Newham council, has expressed interest in developing and promoting the document throughout the council. This will serve to make Newham events more accessible.

Item 6. Integrated Care System with Ryan Suyat, Borough Transformation Lead, NHS North East London and Sam Walker, Engagement and Community Communications Manager, NHS North East London	
6.1 RS and SW presented the North East London Integrated Care System and Place-Based Partnership.	
6.2 Integrated care systems (ICSs) are new partnerships between the organisations that meet health and care needs across an area, to coordinate services and to plan in a way that improves population health and reduces inequalities between different groups.	
6.3 The North East London Integrated Care System is known as North East London Health and Care Partnership (NEL HCP).

6.4 The board is chaired by Marie Gabriel, a Newham resident and	<u></u>
former chair in East London Foundation Trust and across North East	
London Primary Care Trusts, and Chair of the NHS of the NHS Race	
and Health Observatory.	
6.4 North East London Health and Care Partnership is a formal alliance	
of partners with a role in improving the health and wellbeing of residents.	
6.5 Together they set the overall strategy that will guide collective work	
and hold the wider health and care system to account for how services	
are delivered in a more joined up way.	
6.6 Cllr Wilson noted that he sits on the Integrated Care Partnership	
Board at borough level.	
6.7 Patients, resident and community head the structure of the board.	
6.8 47 primary care networks work together at neighbourhood level for a	
population of 30 – 50 thousand	
6.9 Integrated Care Partnership ambition is to "work with and for all the	
people of north east London to create meaningful improvements in	
health, wellbeing and equity."	
6.10 There are seven place-based partnerships, one for each of the	
boroughs. Each has a structure that suits local need and engages local	
partners.	
6.11 London Borough of Hackney and the City of London Corporation	
operate as a single place-based partnership.	
6.12 Place Based Partnership priorities are, Children and Young People,	
Mental Health, Learning Disabilities and Autism, Ageing Well, Primary	
Care and Urgent Care	
6.13 The Integrated Care System standards for participation include a	
commitment to putting people participation at the heart of the work,	
collaborating to identify where a high standard of participation can be	
achieved. Sharing insight and producing plans based on evidence and	
feedback and ensuring accessibility to allow for full participation and	
being responsive to the voice of local people.	
6.14 The board also seeks to identify 5 Voluntary, Community and Faith	
sector (VCFS) representatives for the Newham Health and Care	
Partnership Board	
6.15 Further work will be carried out to refine the co-production process	
6.16 By April 2023, roles on the Newham Health and Care Partnership	
Board will be filled, training and induction provided – this will include	
governance, procedures, context and language of Newham's boards	
6.17 The roles will be refreshed in April 2024	
6.18 AMD asked that to make the meetings accessible, they should be	
held on Zoom and not MS Teams

 6.19 Consideration will be given to using Teams for accessibility 6.20 AMD noted that the Clinical Commissioning Group were already doing some of this work. Are the board using some of the data collected as part of the process? 6.21 RS replied that ICB are building on the work already done to avoid duplication and time wasting. The difference is working across 7 borough and linking in health data and care data for a holistic view. This should allow for better decision making for the transformation of care. 6.22 Cllr Wilson asked where GP's fit into the structure 6.23 RS responded that Primary Care and Newham Health collaborative sit on the board and are very vocal and engaged. Primary Care is one of the 6 joint panel groups. 6.24 Cllr Wilson added, Newham have Primary Care Networks and discussions are ongoing about how the local authority and residents' coproduce. 6.25 SP asked where families of children with additional needs fit in 6.26 RS noted that Babies, Children and Young People group forms one of the 6 joint planning groups with a wider representation across health care. One of the initial areas of focus is children with complex needs and the areas of concern can be outlined as part of successful coproduction. 6.27 AMD asked if board would implement a recognition policy fough this doesn't currently exist. More information will be shared as the expression of interest process continues. 	
Item 7. Service Issues and Actions with Latifat Honey Sarfo, Co-Production and Participation Facilitator	
 7.1 LHS presented the Service Issues raised by Co-Production Representatives 7.2 Issue 1: In April 2021, Thames Water changed the way that council tenants pay for their water and wastewater. Newham, like all other council's and housing associations stopped charging tenants for water and wastewater via their rent, and Thames Water started charging residents directly. Many Newham residents set up payments with Thames Water, yet their rents did not decrease as a result. In essence they were charged twice. These residents are either still paying the higher rate or are yet to receive a rebate for what appears to be an over- charge. Raised by Greenhill Cumberland

 7.3 Cllr Wilson responded that in 2021 all Housing Revenue Accounts (HRA) who were encompassed by this management arrangement, saw the water charge be removed from April 2021. This would not have impacted the rent level, and most would have seen an increase in rent or other services at the same time the water was removed as a charge. As such it is expected that the Gross weekly charge for most would not have seen a notable reduction. 7.4 A HRA is the account in which a council's housing revenue, example a tenants' rent, and housing costs, example, property management and maintenance are kept. 7.5 Additional queries or for verification of transactions on individual rent accounts will be directed to Newham's Income Collection Team. 	
 7.6 Issue 2: Did Newham council carry out an impact assessment on those who are on disabled benefits and pensioners on fixed incomes considering that council tax is going up (4.99%) and 8% increase on rent which is over £500 per annum plus heating bills? Rasied by Greenhill Cumberland 7.7 LHS confirmed Newham did carry out an income assessment ahead of the proposed 2023 – 2024 budget. Details of this will be shared via email following the forum. 	
7.8 Issue 3: Accessible transport serving Newham residents has become inaccessible. Redbridge, Barking, Waltham Forest, Hackney has private transport scheme, but Newham does not. Services such as Dial-a-Ride, Com Cab and Taxi Card are unreliable, limited to one journey a week for many residents. Or they are restricted to in-borough journeys only, operate until 9pm only or no longer provides hospital service. Can Newham investigate providing flexible accessible transport for residents? Raised by VIPON (Visually Impaired People of Newham) 7.9 LHS reported that investigations will take place to identify the issues with available travel providers and how it is impacting Newham residents. Alternative transport provided by Newham council is a statutory provision to meet the needs of residents who receive travel support as part of a care package.	
7.10 Drivers parking on drop curbs and blocking access for vulnerable, disabled and elderly resident. Raised by Ask User-Led Mental Health Group

 7.11 LHS reported that more information is needed for an investigation into be carried out to identify trouble areas for parking on drop curbs in the borough. Action: LHS to follow up and report back before next forum 7.12 AMD noted that drop curbs often fill up with rainwater, some 4 inches deep. Pedestrians who have no other alternative get wet. 7.13 Cllr Wilson noted the council is behind on its Highways improvement programme but are catching up. 7.14 SA added that the council needs to review their signage. 'No parking' signs are driver focused and do not advise to park on drop curbs because of the use for disabled and vulnerable residents. There is a need to educate drivers and road users. 	by: LHS

 8.11 NJ noted the Stratford Police Station is now closed. Along with Plaistow station, this leaves only Forest Gate. There are less places for people with disabilities and vulnerabilities to go for help. 8.12 Cllr Wilson agreed that this is a priority for the council. In recent meetings with the Metropolitan Police Borough Commander, consideration has been given to potentially opening stations/police shops. 	<u>by:</u>
 8.13 SA reflected on the impact of inadequate services on resident's wellbeing, as witnessed during the meeting. SA said, issues cannot continue to be taken out of the forum and must be addressed publicly. 8.14 SA has pledged to raise money for Turkey and Syria after Ramadan. Further details on how members can get involved will be shared in due course. 8.15 SA requested that officers attend forum meetings in person to show commitment.
