Appendix 1 – Discretionary Housing Payment (DHP) Policy 2022/23 Onwards (Priority Categories for Assistance)

- Applicants with severe health condition who receive a significant care package which cannot be easily transferred (as confirmed by Adults or other appropriate services)
- Households who are likely to be able to meet or eliminate their rent shortfall in the near future (usually within 3 months), but require DHP temporarily.
- Households with a disabled adult dependent who are subject to the benefit cap
- > Other vulnerable households as described in the DHP guidance manual.
- To make an award outside the terms of the policy in exceptional circumstances and the authority of the Assistant Director Housing Needs & Supply
