



Procurement

Procurement refers to the process of acquiring goods, services or works from external sources to support the operations of a business. Effective procurement is critical to the success of a business, as it ensures that the business has the resources it needs to operate efficiently and effectively. By carefully selecting suppliers and negotiating favourable terms, businesses can minimize costs, reduce risk and improve their overall operations.

The process typically involves these stages:

- 1. Identifying the need: the first step in the procurement process is to identify the goods or services that the business requires to operate effectively.
- 2. Supplier selection: once the business has identified its procurement needs, it must identify potential suppliers that can meet those needs. This involves researching potential suppliers, evaluating their capabilities and comparing prices and terms.
- 3. Negotiation: after selecting a supplier, the business must negotiate the terms of the agreement including price, delivery schedule and payment terms.
- 4. Contracting: once the business and supplier have agreed on the terms of the procurement, they must sign a contract outlining the details of the agreement.
- 5. Fulfilment: the supplier delivers the goods or services as agreed upon in the contract and the business pays the supplier according to the agreed-upon terms.
- 6. Performance evaluation: after the procurement is complete, the business should evaluate the supplier's performance to determine whether they met the agreed-upon standards and to identify any areas for improvement.
