

The current Local Plan is fundamentally flawed and does not fulfill the duty to cooperate, primarily due to its insufficient allocation for community facilities that fail to address the everyday needs of our diverse population. The existing infrastructure is grossly inadequate, lacking enough space to accommodate all worshippers, particularly women and children, which hinders participation and inclusivity in our community. Merely maintaining the size of the current facility will not resolve these issues; it is crucial that any proposed replacement offers sufficient capacity that reflects the actual needs of our growing congregation. The current facility's shortcomings have already compelled many worshippers to seek alternative locations for their religious activities, which undermines community cohesion and spirit.

I also in the strongest terms oppose the Key Route proposal in the Local Plan, as it will restrict the Mosque's size, limiting community participation in prayer and access to community facilities, and failing to address the limitations of the existing small facility. Moreover, while Newham celebrates its diversity, the current draft proposal overlooks the essential infrastructure needed to support and enhance this vibrant community. In contrast, the landowner's plan thoughtfully incorporates retail shops and housing alongside the Mosque, promoting inclusivity.

It is essential that the Local Plan is revised to effectively address these deficiencies, creating an environment in which all community members can thrive and have their concerns acknowledged and addressed. Therefore, I strongly urge you to consider the landowner's proposal, which prioritizes the welfare of the community.

To guarantee that the Local Plan is legally compliant and effective, essential modifications are required, particularly concerning the insufficient existing facilities that do not address the diverse and evolving needs of our community. Our community is eager to collaborate with landowners and authorities to develop a new facility that genuinely meets our needs, fostering partnerships that benefit all stakeholders. The current rigid policy regarding facility size should be reevaluated through a thorough needs assessment to better align with our community's changing demands, promoting inclusivity and participation, particularly among women and children. Furthermore, the absence of purpose-built facilities for individuals with disabilities underscores the importance of inclusive design that can enhance social connections for our elderly population facing isolation. Additionally, the draft proposal does not capitalise on land for both much-needed housing and expansive community facilities, a gap not present in other progressive boroughs. We also call for the plan to address the proposed key transit routes, ensuring they support the housing and economic growth potential that is vital for the area. By doing so, the plan will not only comply with legal standards but will also cultivate a vibrant and diverse community, boost economic growth in the construction sector, and create local employment opportunities, ultimately leading to a stronger and more cohesive Newham.
