What data do we collect and process

We collect your name, contact details, email address, job title and organisation if applicable and demographic equalities data if you choose to share it.

Why we collect your data

The consultation is a requirement of the Town and Country Planning (Local Planning) (England) Regulations 2012. We collect your data so that we can get your views on the legal compliance or soundness of the Local Plan, as well as its compliance with the duty to co-operate.

The lawful basis for processing your data

The lawful basis we use to process your data as set out in UK data protection legislation is:

Article 6 (a) Consent: the individual has given clear consent for us to process their personal data for a specific purpose.

Article 9 (a) Explicit Consent: the data subject has given explicit consent to the processing of those personal data for one or more specified purposes.

We will only process personal data where we have consent to do so, and you can withdraw your consent at any time. By submitting your personal data in the response form you are consenting for us to process your data and/or consenting to be added to the database. If added to the database, they can be removed upon request.

You can withdraw your consent at any time.

How we use your data

This data is collected, collated and then submitted to the Secretary of State, who will appoint an Inspector to conduct an independent examination of the Local Plan. Demographic data will be processed anonymously to assess the effectiveness of our consultation.

Where you have consented, your contact details will be added to our consultation database for future consultations and updates on the Examination in Public.

At submission representations will be made public on the council's website, including name of person and organisation if applicable making representation. Other personal information will remain confidential.

Representations, in full, submitted along with the Local Plan, evidence base and documents Submission Draft Newham required by legislation to the Planning Inspectorate and to the person the Secretary of State appoints as the Planning Inspector. Contact details will be made available to the Inspector and Programme Officer so they can contact individuals to participate in the Examination.

Consultation database is stored on Mailchimp and accessed by planning policy team only. Mailchimp stores names and email addresses of those on the consultation database in line with Mailchimp policies, particularly its [data processing addendum](#). Please be aware they may store personal data external to the UK specifically in the USA and/or EU.

Who we will share your data with

We will only share your data with the Planning Inspector appointed by the Secretary of State, the Programme Officer appointed by Newham, and within the planning policy team. Your name and organisation (if applicable) will be published on our website along with representations upon submission. Demographic data is not shared with the Planning Inspector or the Programme Officer.

We will not share your personal information with any other third parties unless you have specifically asked us to, or if we have a legal obligation to do so.

How long we will keep your data

Current Facility Limitations: The existing facilities are inadequate for accommodating the diverse and growing needs of our community. The space constraints particularly affect the participation of women and children, limiting inclusivity and engagement.

Need for Expansion: A replacement facility must be larger than the current one to address these deficiencies effectively. Simply replicating the size of the existing facility will not resolve the issues but rather perpetuate the current limitations.

Impact on Community Engagement: The inadequacies of the current facility have led many worshippers to seek alternative locations for their religious practices, which disrupts community cohesion and engagement. A new facility should aim to foster a stronger community spirit by providing adequate space for all members.

Diversity and Infrastructure: Newham is known for its diverse population, yet this diversity has not been reflected in the draft proposal for the new facility. It is crucial that the new facility incorporate infrastructure that reflects and supports this diversity, ensuring that all community members feel valued and included.

In summary, the proposed facility must be designed with a focus on expanding capacity and inclusivity to meet the needs of our community effectively. Addressing these concerns will not only enhance community engagement but also reflect Newham's commitment to diversity and inclusion.

1. **Collaborative Approach:** Our community is eager to collaborate with landowners and authorities to develop a new facility that addresses our needs. We believe that a cooperative effort will yield a solution that benefits all stakeholders involved.
2. **Need for a Comprehensive Needs Assessment:** We strongly advocate for a thorough needs assessment to be conducted. The current policy does not adequately reflect the evolving requirements of our community, particularly regarding the size and functionality of facilities. An updated assessment would ensure that future developments align with actual community needs.
3. **Inclusion of Purpose-Built Facilities:** The current facilities lack accommodations for individuals with disabilities, which hampers their ability to participate fully. Incorporating purpose-built facilities for disabled individuals would support our socially isolated elderly population and enhance community connectivity.
4. **Optimizing Land Use:** The draft proposal does not fully leverage the land's potential for integrating much-needed housing alongside larger community facilities. Other parts of London and similar regions have successfully combined housing and community facilities, and we urge for a similar approach in this proposal.
5. **Future Needs and Land Use:** Privately owned land has been secured to address future community needs. It is crucial that the development plan incorporates these considerations to maximize the land's potential and provide for the growing demands of our community.

In summary, by advocating for a detailed needs assessment, improved policy flexibility, and optimized land use, we aim to create a facility that truly meets our community's needs and supports its diverse members effectively. We look forward to working together to achieve these goals and enhance our community's well-being.
