SUBMISSION OF NEWHAM LOCAL PLAN FOR EXAMINATION

In accordance with the Town and Country Planning (Local Planning) England Regulations 2012 (as amended), Newham Council hereby submits the above Local Plan document for independent examination with the accompanying documents as required by Regulation 22.

Comments received in response to the Draft Local Plan Submission consultation (Regulation 19 Consultation) on 19 July – 20 September 2024 are summarised in the Regulation 22 Consultation Statement, along with the Council's response. Full details of the comments received are all available in Newham Local Plan Submission and Examination Library.

The Council have included a Schedule of Proposed Modifications to address some of the comments received in response to the consultation on the Draft Local Plan (Regulation 19 Consultation), in addition, the Council requests that the Inspector recommends any main modifications, in order to make the Plan sound.

The Council has pursued individual Statements of Common Ground (SoCG) together with a Duty to Corporate Statement with its neighbouring authorities, prescribed national bodies and other relevant duty to cooperate partners. The majority of SoCGs have been agreed and signed, while others are still in negotiation and will be sent to the Programme Officer as they are finalised.

With regard to the Hearing sessions for the Examination in Public, the Council would usually expect them to take place at Newham Council Office (Newham Dockside, 1000 Dockside Road, London E16 2QU). However the Council is happy to look for an alternative venue should this prove unsuitable. The Council is



also happy to livestream on YouTube and hold virtual hearing sessions should the Inspector require them.

Notification will be sent to all those who have previously been consulted on or participated in the Local Plan during its production and have requested to be kept informed, to notify them of its submission.
